

STATEMENT

Introduction

DNV Business Assurance (DNV) has been commissioned by the management of Tempestini SpA to carry out an independent verification of its GHG emissions relative to the 2021 calendar year.

Tempestini SpA has sole responsibility for preparation of the data and external report. DNV, in performing our assurance work, is responsible to the management of Tempestini SpA. Our assurance statement, however, represents our independent opinion and is intended to inform all stakeholders including Tempestini SpA.

Verification Objective

The objective of this verification is to verify conformance with applicable verification criteria, including the principles and requirements of relevant standards or GHG programmes, within the scope of the verification related to: the organizzation's GHG emissions inventory - as described in Tempestini SpA's GHG emission report Inventory year 2021 rev.2 of the 08/03/2023 -and the organization's GHG related controls.

Verification Scope

2021 Greenhouse Gas (GHG) emissions inventory which include: Direct GHG emissions (cat.1), Indirect energy GHG emissions market-based and location-based (cat.2), Indirect GHG emissions from transportation (Cat.3), Indirect GHG emissions from products and services used by the organizations (Cat.4) and Indirect GHG emissions from use of organization's products (Cat.5)

Verification Level of Assurance

The verification was conducted by DNV to a limited level of assurance with the qualification reported in the below Verification Conclusions.

Materiality Level

Errors / omissions which represent, single or aggregated, the 5% of total emissions are considered material.
